### **SECTION 1: INTRODUCTION**

### **1.1 BACKGROUND**

Lagos Mainland Local Government is one of the oldest local governments in Nigeria. It was created in 1976 and currently has its office located at 2, Ondo Street Apapa Road, Ebute Metta West Lagos. Lagos Mainland LGA was one of the first developed places in Lagos. This is because most of the major buildings here were constructed during the colonial era. Lagos Mainland LGA is divided into two main areas: East and West. The LGA has risen to popularity due to the production and sale of local food and clothes within its environs such as Yaba, Oyingbo, Sabo, and a host of others, it is almost impossible to suffer loss doing business in the LGA. Lagos Mainland LGA is an urban setting located at the metropolis of Lagos State with geographical coverage of about 19.5 KM at 7.5 per square meter. It harbors areas that drive HIV infection

A huge population of Lagosians lives on the Lagos mainland, and most industries are located there. Lagos Mainland LGA is known for its music and nightlife, which mostly are located in areas around Yaba, Sabo, Oyingbo, Makoko, and Otto, etc.

Lagos Mainland LGA is regarded as one of the LGAs with the highest numbers of Orphans and Vulnerable Children who are living with the Human Immunodeficiency Virus (HIV). HIV prevalence for Lagos Mainland LGA is estimated at 0.4% according to NAIIS-2018, while the knowledge of HIV prevention among adolescent females and males is 4.0% and 4.2% respectively (NAIIS-2018). Lagos State Government estimates the population of Lagos Mainland LGA (LMLGA) at 449,900 (220,768M, 229,132F) with 97,826 children aged 0-14yrs, 218991 aged 15-64yrs. Lagos City Population 2016 (www.citypopulation.de). Despite the huge numbers of millionaires in LMLG, about 66% of the population lives in slums. This has contributed to the city of Lagos being dubbed as the "mega-city of slums" where lots of Orphans and Vulnerable Children reside.

LMLGA has a record of 52 hospitals which is inclusive of 10 Primary Health Centres (PHC) and 5 General Hospitals and 37 private hospitals providing several medical services including HIV management. Mainland LG currently has 58 Government primary schools, 22 Secondary schools, 4 tertiary institutions, 1 Adult education center with 1 ICT center yet they are insufficient for the alarming number of OVC within the LG. With over 10 registered community-based organizations, 3 orphanage homes, and 5 recreational centers, OVC is assured of the provision of psychosocial services. OVC in Lagos Mainland LGA like other LGAs of Lagos State are faced with issues such as poverty-stricken homes, inadequate access to education, malnutrition, health and other social support, terminally ill parents or care-giver, infected/ affected with HIV, Dropping out of school as a result of insufficient or no financial support.

Caregivers of OVC not having a means of economic sustainability does not only have a devastating emotional and financial effect on already vulnerable children and their households, but the situation is also capable of exposing the OVC to several risks such as

early marriage, child labor, high debt profile, vulnerability to health issues, HIV infections and a cycle of multi-generational poverty. Despite various efforts made by the Lagos State government and numerous supports for OVC and their households by various OVC program implementing organizations such as Association for Reproductive Family Health (ARFH), FHI 360, and other agencies, there are still some various needs of OVC which requires urgent and continuous attention.

# SECTION 2: OBJECTIVES OF THE LG OPERATIONAL PLAN

#### Objective:

To 'Have an all-inclusive OVC operational plan that will serve as resource mobilization and advocacy tool for OVC activities in Lagos Mainland LGA'.

The specific objectives are to:

- Identify the key activities in each thematic area that can be implemented by different stakeholders in the LGA.
- Have a document that can be used to engage potential funders of OVC activities in the LG.
- Estimate the level of funding available from different sources.
- Enumerate the critical factors/assumptions responsible for implementation success.

# SECTION 3: KEY ACTIVITIES IN THE OPERATIONAL PLAN

#### a) Health

- Conduct quarterly HCT community outreaches in Lagos Mainland LGA
- Conduct quarterly community food demonstration sessions targeting pregnant women and mothers with children 0-5yrs using the caregivers' forum
- Provide Emergency support fund for health at 10,000 each for 80 malnourished and sick children to the facility for treatment annually

#### b) Safe

- Conduct bi-monthly kids club recreational activity to reform VC in the community
- Conduct Quarterly sport recreational activities for 800 Children in Lagos Mainland LGA communities annually
- Provide birth certificate for 800 VC annually

#### c) Stable

- Provide skill acquisition program in liquid soap making, makeup, hair barbing & hairdressing, etc for 200 adolescents annually
- Provision of Startup Materials for 240 women annually
- Provision of CCT for 120 women and widows

#### d) School

- Conduct Monthly free adult literacy training for caregivers and Household head
- Establish ward level free Early Child Development Centres in Lagos Mainland

Provision of educational materials for 400 VC in Lagos Mainland LGA

#### e) Monitoring & Evaluation

- Conduct Monitoring and supervision of VC related activities in several communities in the LGA
- Monthly VC data entry into and exporting NOMIS
- Conduct Quarterly M&E data review meetings

#### f) Leadership and Coordination

- Conduct establishment of VC steering committee/ CQIT in Lagos Mainland LGA
- Conduct VC steering committee/ CQIT quarterly Meeting in Lagos Mainland LGA
- Conduct meetings of existing Child Protection Committee meeting and set up more CPC across other WARDs in Mainland LGA to address Gender and Sexual Abuse Issues

### **SECTION 6: CONCLUSION**

The Mainland LGA OP will at the end of its implementation address OVC issues such as poverty-stricken homes, inadequate access to education, malnutrition, inadequate health and other social support, terminally ill parents or care-giver, infected/ affected with HIV, dropping out of school as a result of insufficient or lack of financial support.

It will also address issues of economic sustainability for Caregivers of OVC which has exposed the OVC to several risks such as early marriage, child labor, deep debt profile, vulnerability to health issues, HIV infections, and a cycle of multi-generational poverty.
